## Ski Atlantic Seniors Club Membership Application Instructions, 2025-2026

To purchase a SASCPass, you must first be a Member of the club and pay your Annual Dues of \$30, and then you <u>add on</u> the fee for the SASCPass, and send payment for the total amount of the two (see below for this year's prices).

Membership Cards will be sent my regular mail once after applications <u>and</u> payments are received. We are working to update our list of available discounts (hotels, sports stores, restaurants, and day ticket discounts at some ski hills), and a Membership Card will make it easier when requesting these discounts. If you have also purchased a SASCPass your Membership Card will have your SASCPass number printed <u>prominently in red</u> on the front of your card, and there will be a sticker on the back with a barcode that can be used to sign in at hills that support digital sign-in. You should be prepared to present picture ID if necessary (for example your driver's license) both at the hill and at other merchants.

SASC Membership entitles you to attend all Club events such as Ski Trips, Kell Antoft Days, Summer Social, and the Annual General Meeting, as well as discounts at selected merchants in the Maritimes (see the "Discounts" page on the club website). To qualify for Membership you must be 55 years of age, or a spouse or partner of a SASC member.

The optional SASCPass add-on entitles you to ski at participating ski areas where the ski pass is accepted in NS, NB, & PEI for the current season. (Note that Crabbe Mountain and Mont Farlagne are no longer participating in the club's ski pass arrangement, but will recognize the SASCPass for the NOMAD discount on their posted rates for the applicable age group). To purchase a SASCPass for the 2025-26 ski season **you must be 60 years of age** or over by March 31, 2026.

Rates for 2025/26: Annual Membership Dues are \$30. For the add-on SASCPass the early bird special rate of \$408.00, applications must be received by the Registrar on or before October 31<sup>st</sup>, 2025. After that date the SASCPass is \$576.00. All fees must be paid in CDN funds, and taxes are included. A reminder that at the request of the participating ski hills, the early bird rate now ends on October 31.

There are two ways to apply for membership: The fastest way is to use the online electronic application form, and send your payment via Interac e-transfer. The other way is to print out the paper application form and send it with cheque payment by regular mail (see below on next page for details).

If you use the <u>electronic</u> application form, there is no need to print it. Simply follow the "Apply Online" link on the club website, fill in all the required fields, click "Submit Application", and send your payment as outlined below. You will receive an automated response confirming receipt of your application, <u>with a printable copy of your completed application form</u>. Your membership card will be sent to you by regular mail as soon as the processing is complete. <u>If you do not receive the automated acknowledgement email</u> (within minutes of submitting!) please contact the club registrar Mary Drake at (902) 826-9199.

**E-TRANSFERS**: If you use online banking at your chartered bank or credit union you can etransfer your payment to **seniorskier60@gmail.com**. (A security question is <u>not</u> necessary and funds will deposit automatically.) In the box provided for a note, make sure it shows your name to help us match up your payment with your application form.

**REGULAR MAIL** option: Alternatively, and especially if you are unable to use the e-transfer method of payment, you may use the printable application form from the website, fill it in, and mail it (with proof of age/id if required) with your payment cheque to: SKI ATLANTIC SENIORS' CLUB, P.O. BOX 3076, TANTALLON, NS B3Z 4G9.

<u>It is very important</u> that you enter your email correctly on the application form, because this is the address we will use to send your acknowledgement. <u>If you are a new member</u> please fill in your date of birth on the form, and proof of age must be provided (i.e. scanned copy of driver's license, passport or birth certificate) with your application or as soon as possible after.

**Refund Policy** for the SASCPass only: The SASCPass fee (minus any days skied at last year's SASC rate per visit paid to the hills) will be refunded only in the event of an injury or illness that prevents the Member from participating in skiing for the 2025-2026 season. The request for refund must be in writing outlining the circumstances, to be received by Mary Drake, the Registrar by January 15. After January 15 the refund will be reduced and based on 50% of the SASCPass fee. After February 15 no refund requests will be accepted.

## **EXCLUSION OF LIABILITY:**

- 10(1) Members acknowledge and agree that skiing is a challenging and dangerous sport. Members are responsible and assume all risk for their own personal preparedness and safety and all risk of injury or fatality when participating in any club program or event including, without limiting the generality of the foregoing, ski days, ski trips, Kell Antoft Day, annual golf tournament, and annual general meeting. Members agree to release, indemnify and hold harmless the club for any personal injury, death and economic or non-economic losses resulting from: (a)-the inherent risks, dangers and hazards of alpine or cross country skiing or snowboarding; (b)-the use of ski lifts; (c)-the collision with natural or man-made objects, with skiers, snowboarders or other persons; (d) skiing and travel to and from ski areas and club functions and skiing within or beyond (outside) the ski area boundaries.
- 10(2) Members waive all claims against the Officers, Directors or other Members their successors or assigns with respect the risks, economic and non-economic losses outlined in 10(1).
- 10(3) Members are responsible for their own travel, health and accident insurance.
- 10(4) Members shall abide by the Alpine Responsibility Code and the Cross Country Responsibility Code as well as the rules and conditions established at Participating Hills and other hills.
- 10(5) No Member in his or her individual capacity is responsible for any debt or financial liability beyond the amount of any subscription, annual dues or special event fees payable to the Club
- 10(6) Members may make comments, suggestions or other representations related to safety and liability through any Director or Officer.
